We have heard Mr. Kaushik N. Sharma, learned counsel appearing for the applicant as well as learned counsel appearing for the other side.

2. The relief claimed in this application is for a permanent injunction against the 1st respondent from illegally dumping plastic wastes and solid wastes at Ambattur/Korattur Dairy and also for a direction to remove the existing plastic wastes and solid wastes and to use only plastic which can be recycled by adhering to the Indian Standard Guidelines for Recycling of Plastics.

3. As per the order of this Tribunal, the 1st respondent has complied with all the grievances addressed by the applicant in this application.

4. In the additional counter dated 9.2.2016, the 1st respondent has stated that the successful bidder viz., M/s. Chitra Plastics, Salem has remitted the total bid amount and the work order has been issued on 8.2.2016 and the last date for completely clearing the waste plastic covers from the metro dairies by the above successful bidder is 26.2.2016.

5. Since all the grievances have been addressed, the application is closed with a direction to the 1st respondent to adhere to the undertaking and various orders of this Tribunal. There shall be no order as to cost.
